

TGIF SHOWDOWN

Rules and Regulations

1. Must complete and submit participant registration form by Friday, March 9, 2018.
2. Must be available to play during the TGIF Showdown on Friday, June 29th 7:00-10:00pm.
3. Each submittal will be reviewed by a selection committee. A maximum of 5 bands may be selected to participate in the TGIF Showdown. There is no limit to the number of bands that wish to apply. Selected bands will be announced by Monday, April 2nd, 2018.
4. Understand this is NOT A PAID performance.
5. Each band's set must fill approximately 15 minutes but must not exceed 20 minutes.
6. Consider this an audition for the opportunity for future employment, but is not a guarantee.
7. Any distasteful behavior will result in the automatic disqualification at the hands of management and/or judges.
8. Performers will be judged on Planning/Preparedness, Originality, Interaction with Audience, Quality of Performance, and Presentation
9. Showdown winner will receive \$500 and the opportunity to perform at the Historic Morganton Festival in September. The appropriate stage and evening will be determined by HMF, Inc. staff.

In the event the performance of the Artist is cancelled by agreement or if the performance by the Artist because of events beyond the reasonable control of the Artist such as accident, riots, strike, illness or other acts of God, the Artist shall be relieved of all responsibility to perform as required and the Purchaser shall not be required to pay the fee if a fee is applicable.

Agents signing on behalf of an Artist and/or the Purchaser assume no personal liability for the performance of this Agreement; however, such Agents do represent to the other party that such individuals have the authority to sign on behalf of and bind such party.

In consideration of being a vendor, service provider or other participant in one or more events conducted by Historic Morganton Festival, Inc., the undersigned agrees to indemnify, protect and save harmless the Historic Morganton Festival, Inc. from all claims, liability or lawsuits, including reimbursement of attorney fees in defending such claims and damage to real or personal property which arises out of, or results from the acts or omissions of the undersigned or resulting from the activities carried on by the undersigned and its employees, agents and representatives.

Any changes, additions and/or deletions to this Agreement must be initialed and dated by both parties to be considered valid.

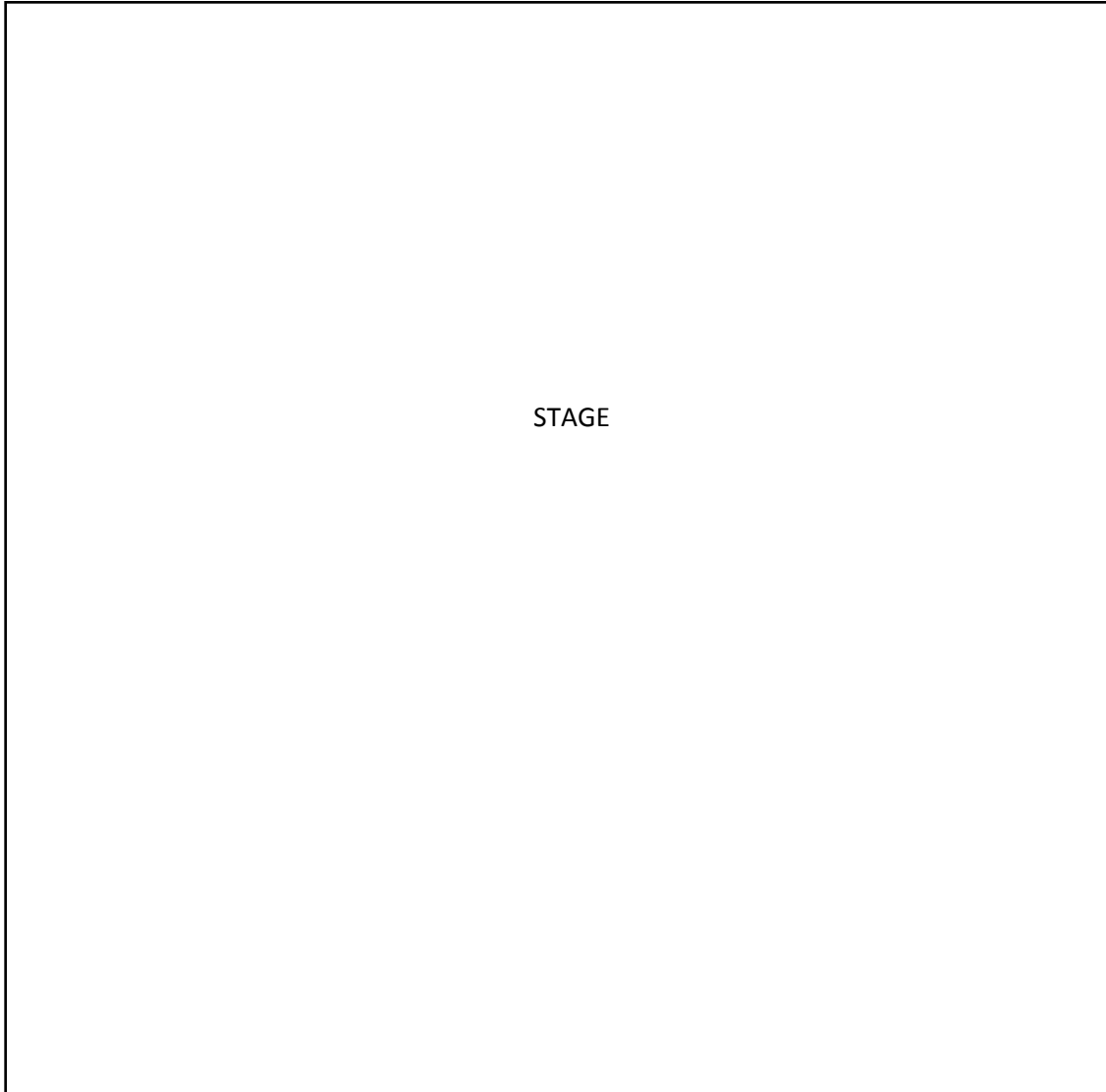
